- At least a 3.0 GPA for undergraduate work and a grade of C or better in all pre-professional required coursework. Official transcripts must be sent to SMU Graduate Admissions.
- Curriculum vitae outlining professional or work experience details
- Written response of approximately 300-400 words to a prompt provided by the Office of Graduate Admissions
- Two completed recommendation forms/letters from professional references (available through online Saint Martin's University graduate application) and one additional reference's contact information. Each recommender will have the opportunity to submit a letter on the applicant's behalf in which they may further detail the applicant's qualifications and capacity for graduate work and/or the teaching profession.
- WEST-B score report or scores on the SAT/ACT that meet minimum requirements as set by the Washington Administrative Code (WAC).
 - For SAT/SAT, official score reports must be sent to Graduate Admissions.

 - WEST-B score reports will be available on your WEST account a few weeks after taking the exam. You will be required to provide your score report to Graduate Admissions.

- Cleared fingerprints documented by a local Educational Service District (ESD). Fingerprints from other law enforcement agencies are not accepted.

- I must obtain Pre-Residency Certificate clearance from OSPI for the State of Washington as part of my application process and must renew it before I can begin my student internship if it has expired or will expire prior to completing my internship.
- Completion of Saint Martin's University teacher education/school counselor/master's program does not guarantee certification.
- Any falsification or deliberate misrepresentation, including omission of a material fact, in completing the Pre-Residency Certificate clearance can be grounds for Saint Martin's University non-recommendation and/or OSPI denial of certification.

The following will show you how to access the Pre-Residency Certificate Clearance application, which is required for all applicants to education certification programs in Washington State.

A few things to keep in mind before starting your pre-residency certificate clearance application:

- When you create your initial account, the full account will be created after a waiting period of 1 hour. Once the initial account is completed by submitting basic demographic information, applicants must wait one full business day before the Pre-Residency application itself appears as an option to fill out. The whole process will take 2 days to complete from start to finish. So please plan ahead.
- You will need 3 character references, with physical addresses, phone numbers, and email addresses (optional). These are required fields and without them, you cannot complete your application.
- Processing these applications can take a while, so please make sure you get all the way to the end and ensure you reach the final screen. No receipt of processing will be given to you at the end. As long as you've chosen Saint Martin's University as your institution, your application can be found and processed when necessary.
- You should have already completed your fingerprinting requirements through a local Educational Service District (ESD). If you haven't been fingerprinted by a local ESD, your pre-residency application may not be completed.
