Due to Year Round Pell eligibilty, any student who is eligible for Pell Grant and enrolled for Summer will automatically be packaged with Pell Grant for Summer. An Undergraduate student must be enrolled in at least 3 credits to receive Pell Grant. Spring term Pell grant awards may be adjusted dependent upon a student's enrollment in each term. You are not eligible for Direct Stafford Loans if you are registered less than half time. This is less than 6 credits for undergraduates and less than 3 credits for graduate students.
