Advisor, committee member, chair, co-chair, or referee

Description:

The last and first name of each individual should be separated by a comma, and followed by a single space. If multiple names are entered, each name should be entered on separate lines.

Description:

The name of the institution making the work available, and is most responsible for making digitizing and archiving the work. For example, Saint Martin's University will be the entry for all theses and dissertations deposited in the Saint Martin's University Theses and Dissertations Collection.
