**In consideration of being allowed to participate in any way in Saint Martin's University Dragon Boat Festival, and related events and activities, and in the athletic sports program (collectively the "Event"), the undersigned acknowledges, appreciates and agrees that:**

I am aware of the risks and hazards inherent in the sport of dragon boat racing, and am aware that the risk of injury from such activities is significant and includes the potential for permanent paralysis and death. I am aware that, while particular rules, equipment, and personal discipline may reduce these risks, the risk of serious injury or death does exist and cannot be completely eliminated.

I knowingly and freely assume all risk, loss, damage, or injury, whether foreseen or unforeseen, including death, that may be sustained by me or by my property, as applicable, while engaged in the Event. I assume full responsibility for my participation in the Event, and I willingly agree to comply with the stated and customary terms and conditions for participation in the Event. If, however, I observe any unusual significant hazard during my presence or participation in the Event, I will remove myself from participation and bring such to the attention of the nearest official immediately.

In consideration of being allowed to participate in the Event, I, for myself and on behalf of my heirs, assigns, personal representatives, next of kin, executors, administrators, and agents, hereby voluntarily assume any and all risks associated with the Event and hereby waive, discharge, release, covenant not to sue, and hold harmless Saint Martin's University, and Kaikane USA, Inc., and their directors, officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the Event ("Releasees") for any and all liability, medical expenses, claims, causes of action or demands of any kind or nature whatsoever that may arise by or in connection with my participation in the Event, whether arising from the negligence of the Releasees or otherwise, and hereby agree to defend, indemnify, and hold harmless Releasees against any and all liability, claims, or causes of action arising out of, or in any way connected with my participation in the Event; provided, however, that this waiver of liability and indemnification does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct by Releasees.
